Backwater Artists Group are a group studio with an ethos of shared skills and ideas for the promotion of visual arts. In order to fulfill this members have to give of their time and participate in the activities of the group.

The criteria for membership is:

- (a) The artist must be willing to commit time to the activities of the group and use the studio space.
- (b) Allocation of spaces is conditional on a proven need for working studio space.
- (c) The Artist is a Professional Practising Artist.
- (d) Availability of studio space.

- I have been awarded tax exemption status by the Revenue commissioners or I am on Schedule D as self-employed artist in Northern Ireland.
